Bike Exports Sustain High Values, But Quantities Are Down

WASHINGTON, D.C.—Exports of U.S.-made bicycles through October 2006 reached less than 80 percent of the number shipped through the first three quarters of 2005. The big change was in adult-sized bikes. Average perunit values, though, sustained remarkable strength.

U.S. Department of Commerce figures show that adult-sized bike shipments were down by 29 percent, or more than 21,000 units. The slippage began early in '06 and accelerated. Shipments were off by 13 percent through the first quarter and down by 26 percent at the end of June. The biggest changes have been in shipments to Latin America, The Netherlands, and the smaller, mostly Nordic, European countries.

A sustained increase in value helps offset the slide in units, however. Total declared value of all bike shipments was \$43.5 million, an overall 10 percent drop from last year not commensurate with the change in units.

Small-wheeled bikes' total value actually went up by 10 percent to nearly \$5.7 million, reflecting a substantial average value of \$190. Full-sized bikes' value totaled \$37.8 million, a 12 percent drop, but an unprecedented \$725 average export price.

Frame-fork combos, reported in kilograms, were down 23 percent in volume but up by 8 percent to \$45.9 million in total value. The average price per kilogram topped \$60.

U.S. suppliers are not necessarily suffering from the decrease in exported units. Bikes and frames exported from the United States are high-end models and do not begin to reflect major U.S. suppliers' overall sales in foreign countries. All but those very high-end bikes are made in and shipped directly from Taiwan and China to their destination ports. **BRAIN**
